The Callender City Council Meeting was called to order at 6:30 p.m. at the Callender Community Center by Mayor Randy Hanson Present: N. Martens, D. Lee, W. Martens, K. Simonson, and K. Jondle.

Guests present were Luke Fleener to share his experience and the plans he has if he is elected the next Webster County Sheriff. Fleener has 30 years of experience, done a substantial amount of training, and believes we need more law enforcement within Webster County since it is the 13th largest county in the state.

Austin Morrow was also present to discuss the current Thomas Street Project and that as of now we are still on time with the original completion date. The project has had a few change orders that were needed due to issues that were found while the street was torn up.

Paul Macken was also present to share a few ideas he had with snow removal. Public works thanked him for his suggestions and he said he would take those into consideration.

Cynthia McKeeham was also present to ask the city for any information that anyone might have in regards to the ownership for the Prairie View Apartments. All that could be shared is what was on the Webster County Assessors page.

In regards to the property at 611 Thomas Street at this time it will be tabled until the November Meeting so that the council has time to look at the property and see what options that they can come up with for the property.

Clerk shared that the new website for the City of Callender is up and going. The web address is cityofcallenderiowa.com. All the necessary forms are online such as building permits and utility applications. You can also sign up for Webster County emergency alerts. Citizens can then pick Callender and you will get emergency alerts for Callender send right to your phone. Online payments are also something that will be online soon. The clerk on will be gone for training Oct 21st until Friday October 23rd in Des Moines. Planning and Zoning are working on updating the ordinance for planning and zoning.

The librarian Kim Anderson was present to share that the library is now open again at full capacity. She will be working to get all programs up and running.

Public Works has been working on various items including items for the current street project, including getting items ready for the colder months ahead. He also talked to the council about the possibility of getting a Bobcat for the city. He feels that more things would be able to be completed around town with the Bobcat rather than the tractor. The Van Wert company has also been in town installing the new water meters. The electric meters will be installed in the next few weeks.
