## CITY OF CALLENDER – CITY COUNCIL MEETING MINUTES August 4, 2020

The Callender City Council Meeting was called to order at 6:00 p.m. at the Callender City Park by Mayor Randy Hanson Present: N. Martens, D. Lee, W. Martens, K. Simonson, and K. Jondle.

Guests were Austin Morrow from the MER Engineering. He shared information about the Thomas Street Project what they were currently working on. While working on the water main it was determined that additional shut off values would be installed. The question was brought up in regards to storm water tile that runs under the corner of Thomas Street and Mortimer. A. Morrow will work with Jamie Johll to make sure that both the county and city are aware of what will be under that street.

Bill Kahl and Mark Campbell were both present as several citizens had expressed concern about what coming back into their homes from what they believed were tiles. While looking at the storm water tile it appeared that several of the lines fall within the county drainage district. M. Campbell along with B. Kahl will work with Phil Hood to see if they can find the source of the backup.

The City is still waiting on additional information from MER Engineering to see what the lines are for the street between Hilda and Charles.

City Clerk stated that she was still waiting on additional information for the storm siren. The county at this time has ordered the sirens and as far as the County knew the City was a go for the grant. The Clerk had already contacted the IA Dept of Homeland Security and was just waiting to hear from them.

John Horrell stated that our lagoons were extremely low but nothing to be concerned about.

Public Works shared that he helped clean up the park, got new tires put on the city truck.
