J. Horrel shared that the brine pump is still having issues. We had a inspection done with the DNR for the waste water and it was found that we have a broken value in one location. J. Horrell has contracted Kahl Construction to have him fix it. The lead and copper testing will be coming and he will be working with M. George on this.
